

RESOLUTION 97-12

A RESOLUTION OF INTENT TO CREATE THE
GEORGETOWN LAKE FIRE SERVICE AREA,
GRANITE COUNTY

WHEREAS, the Board of County Commissioners of Granite County has received a petition requesting the creation of a fire service area, to be known as the Georgetown Lake Fire Service Area; and,

WHEREAS, the proposed fire service area would include lands in both Granite County and Anaconda-Deer Lodge County; and,

WHEREAS, said petition was signed by at least thirty (30) owners of real property within the Granite County Division of the proposed fire service area; and,

WHEREAS, the boundaries of the proposed fire service area within Granite County are shown and described as Exhibit A, attached hereto and made a part hereof; and,

WHEREAS, the Board is authorized to create fire service areas as provided by Section 7-32-2401, et. seq., MCA.

NOW, THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of Granite County that it establishes its intention to create the Georgetown Lake Fire Service Area (Granite County Division) and that the proposed boundaries of the Granite County Division are shown and described on Exhibit A; and,

BE IT FURTHER RESOLVED, that it is anticipated that fire protection services would be provided by the existing Georgetown Lake Volunteer Fire Company; and,

BE IT FURTHER RESOLVED, that it is anticipated that the Commission would appoint members to a board of trustees to govern and manage the affairs of the fire service area, until elections are held; and,

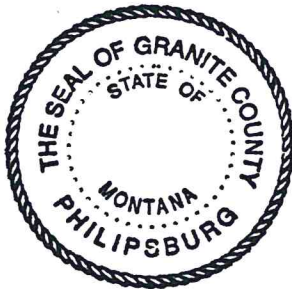

BE IT FURTHER RESOLVED, that it is anticipated that services would be funded by assessments made within the fire service area, that owners of all inhabitable structures or businesses would be assessed for fire protection service, and that the annual assessment for such services would be approximately Sixty Dollars (\$60.00) for each inhabitable structure or business.
