RESOLUTION 2014-7

A Granite County Resolution for Expanding the Boundaries of the Flint Creek Fire Service Area

WHEREAS, a petition signed by at least thirty (30) owners of real property in the proposed expanded service area of the Flint Creek Fire Service Area was received by the Granite County Board of Commissioners on January 7, 2014; and

WHEREAS, after verification of the signatures of the owners of real property on the petition, by the Granite County Clerk and Recorder and the Granite County Treasurer, on February 25, 2014 the Board of Commissioners adopted a resolution of intent to expand the Flint Creek Fire Service Area as required by Section 7-33-2401(2) MCA, and set a Public Hearing on the Petition for April 1, 2014, at 10:00 A.M.; and

WHEREAS, the Public Hearing Notice was published in the Philipsburg Mail on March 20, 2014 and March 27, 2014 as required by Section 7-1-2121 MCA; and

WHEREAS, at the Public Hearing on April 1, 2014, the Granite County Board of Commissioners received and accepted one written comment in favor of the proposed expansion. The Board of Commissioners heard general comments from several members of the public and the petitioners. No written or oral protests to the expansion to the Flint Creek Fire Service Area proposed in the Petition were received by the Board of Commissioners.

NOW THEREFORE, be it RESOLVED:

1. That the boundaries of the Flint Creek Fire Service Area shall be altered and expanded to include the following additional real property:

Township 7 North, Range 15 West (T7N, R15W) Sections: 1, 12, & 13

Township 7 North, Range 14 West (T7N, R14W) Section: 6

Township 6 North, Range 16 West (T6N, R16W) Sections: 25, 26, 35 & 36

Township 6 North, Range 15 West (T6N, R15W) Sections: 19, 20, 29, 30, 31 & 32

Township 6 North, Range 14 West (T6N, R15W) Sections: 19, 20, 28, 29, 30, 31, 32, 33, & 34

Township 5 North, Range 16 West (T5N, R16W) Section: 1

Township 5 North, Range 15 West (T5N, R15W) Sections: 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 22, 23, 24, 25, 28, 29, 32 & 33

- 2. That the residents of the expanded area of the Flint Creek Fire Service Area may hereafter receive fire protection in accordance with Section 7-33-2402 MCA; and
- 3. That the Board of Trustees of the Flint Creek Fire Service Area shall assess a fee on structures and undeveloped land within the expanded Flint Creek Fire Service Area as provided in Section 7-33-2404 MCA; and
- 4. That this resolution and the expansion of the Flint Creek Fire Service Area shall become effective sixty (60) days after passage of this Resolution.
