

RESOLUTION 2024-1

A GRANITE COUNTY RESOLUTION
ESTABLISHING REGULAR COMMISSION MEETING DATES, AND
REGULAR COURTHOUSE OFFICE HOURS FOR CALENDAR YEAR 2024

WHEREAS, Montana law at Section 7-5-2122, MCA, requires that the governing body of the county shall establish by resolution regular meeting dates and notify the public of those dates; and,

WHEREAS, the Board of Granite County Commissioners has agreed to hold regular meetings every Tuesday in calendar year 2024 and special joint meetings with the Towns of Philipsburg and Drummond on quarterly basis at mutually agreed upon locations around Granite County; and,

WHEREAS, due to holidays and certain county business arising that is required to be on a non-regular meeting day, another day or days of the week may be substituted or added with proper public notice; and,

WHEREAS, the Board of Granite County Commissioners is also authorized to set the regular office hours for the Granite County Courthouse and desires to set those hours herein.

NOW, THEREFORE, BE IT RESOLVED that the Board of Granite County Commissioners hereby sets regular Commission meeting dates as every Tuesday in calendar year 2024 and may hold special joint meetings on a quarterly basis at mutually agreed upon locations around Granite County for the calendar year 2024.

BE IT FURTHER RESOLVED that due to holidays and certain county business arising that is required to be on a non-regular meeting day, another day or days of the week may be substituted or added with proper public notice.

BE IT FURTHER RESOLVED that meetings may be called or canceled by the Board of Granite County Commissioners as necessary to conduct county business at a time and place to be announced by proper public notice.

BE IT FURTHER RESOLVED that the office hours for the Offices of County Treasurer, County Clerk & Recorder, Clerk of District Court, and County Attorney shall be from 8:00 am to 5:00 pm Monday through Friday (including noon lunch hour) except such offices will be closed for all state holidays. Additionally, all Granite County Courthouse Offices may be closed at noon, during lunch hour for the County employee Christmas luncheon on a date in December 2024 with notice to the public being provided by newspaper notice which shall also be attached to the on the website and northside Granite County Courthouse doors).

BE IT FURTHER RESOLVED that, special Board of County Commissioner meetings may be held, as set and as allowed for by law, and that are properly noticed to the public.

BE IT FINALLY RESOLVED that this Resolution is to have an immediate effective date.
